
Detentions Average by year





Significant Events for May

- Felony Menacing: A father and son got into an argument in their residence. The argument turned physical. Both parties received injuries from the other. The son grabbed a knife and threatened his father. The father refused to file any charges.
- Trespass/M-1: A resident called the Sheriff's Office to report a vehicle parked on his property. The driver was refusing to leave his property. Deputies arrived and determined the driver had some suicidal thoughts and was taken to St. Anthony's for treatment and evaluation. There was an attempt to locate on the driver out of Edgewater PD for possible suicidal comments by CO.

Citizen Compliments:

- Officers responded to a residence on a party threatening suicide. The party complemented the way the deputies were patient and listen to what he had to say. He was very appreciative of the respect he received.
- John Dunham: I have received outstanding comments from my employees about our Gilpin County Deputies. They tend to stop by my business at closing time or watch from a distance when my employees close the store at night.
